

1. Types of tax that concern most people

Please pay before the due date. The public services we offer and the facilities you use rely on your tax.

| Type of tax | Who pays | Contact |

| Local inhabitants tax | Persons living in Tsuyama city as of January 1 of the year in question and who have had more than a certain amount of income in the preceding year (excluding the income from overseas.) Also persons not living in Tsuyama but own a property in the city. * The tax is levied according to the amount of income. | Taxation Division Tel. 0868-32-2015 |
| Enterprise tax (individual) | Persons who own business offices or facilities in the city. | Taxation Division Tel. 0868-32-2017 |
| Fixed asset tax | Persons who possess a piece of land, a property or <u>+depreciable assets</u> in Tsuyama city as of January 1 of the year in questionBusiness owners living in Tsuyama | Taxation Division (Residential property) and land Tel. 0868-32-2016 |
| Urban planning tax | If your land or property is located in the areas designated for urbanization, you will be levied for urban planning tax. | (Depreciable assets) Tel. 0868-32-2017 |
| Light motor vehicle tax | Persons who possess a motorbike, a light motor vehicle or a special vehicle such as a forklift truck with the engine capacity less than 660cc as of April 1 of the year in question. * The tax is levied according to the engine capacity, type and usage of the vehicle. * Payable once a year on May 31 | Taxation Division Tel. 0868-32-2017 |

<u>+Depreciable assets</u> are items that a company purchases for long-term use in their business which include equipment, furniture, machinery, tools, etc.

2. How to pay tax

(Contact: Tax Payment Section, No. 1 counter on the 2nd floor of the City Hall Tel. 0868-32-2014)

You can use bank transfer which will debit the amount from your bank account or post office account (it has to be set up beforehand), or pay at any bank on the list below using a tax notice which is issued by the City Hall. For those persons who receive salary, local inhabitants tax will be deducted together with prefectural inhabitants tax from your salary.

Your tax payment is due on the last day of the month, however, if it falls on a holiday, you have to pay on the first of the following month, except for December (due on the 25th.) Please be aware that paying tax after a designated deadline will incur a penalty charge according to the length of overdue period.

Necessary documents

·Personal seal ·Alien registration certificate, passport or driving license

·(If someone else is applying on your behalf, s/he has to bring a power of attorney.) ·Service fee: 300 yen per case


